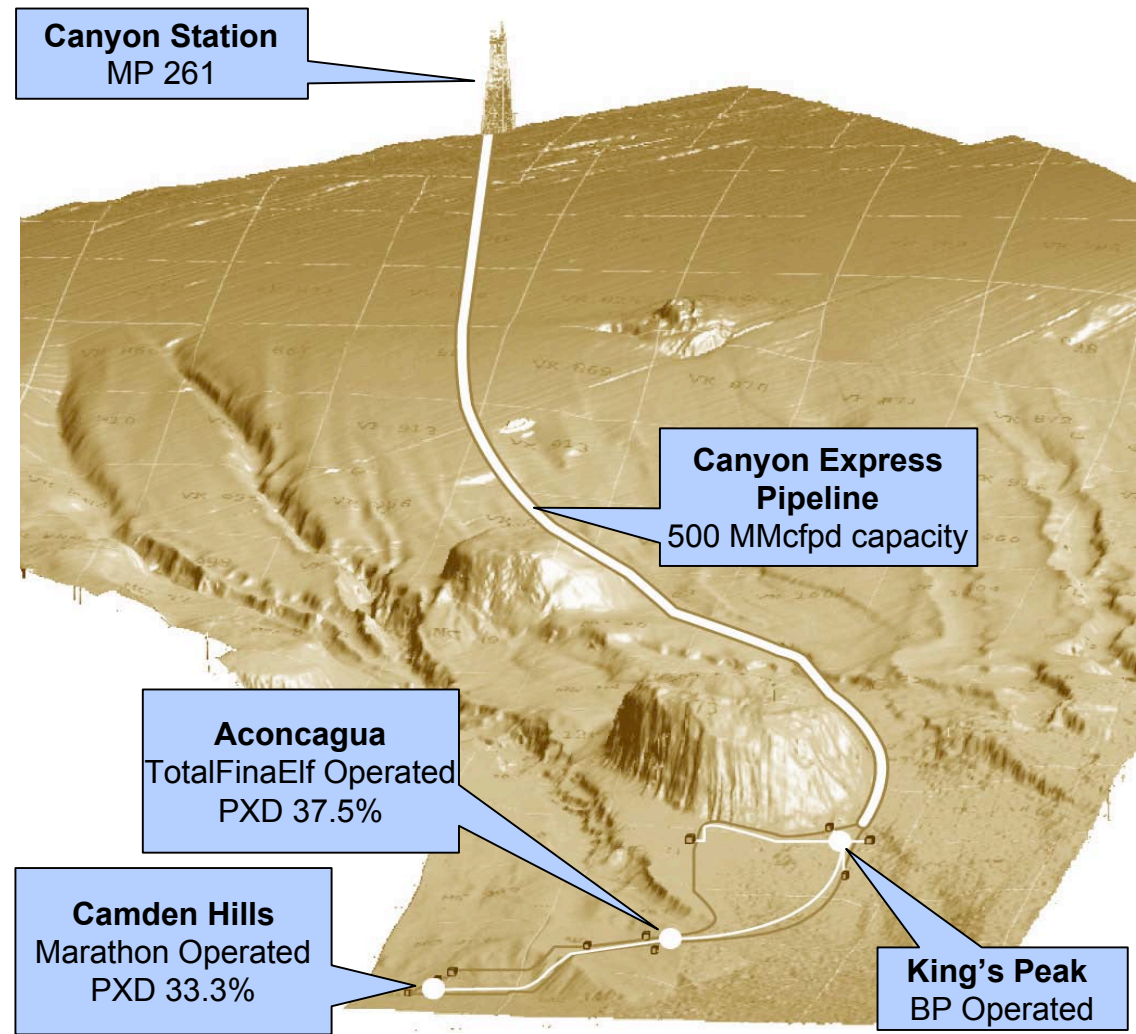

Canyon Express – Deepwater GOM

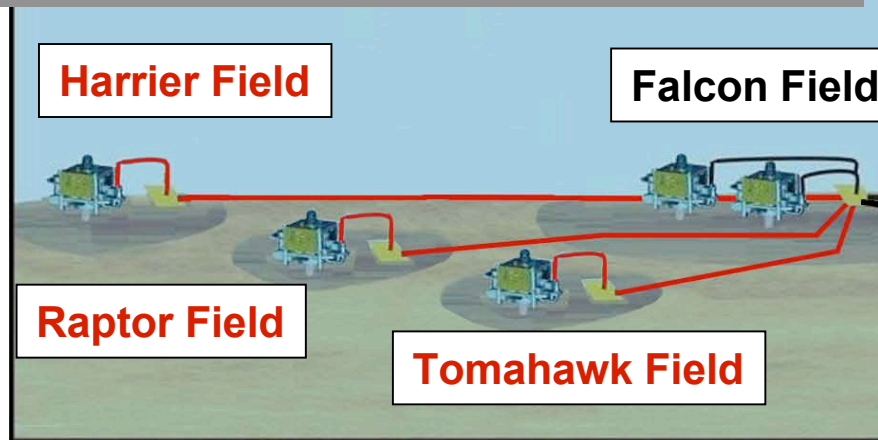
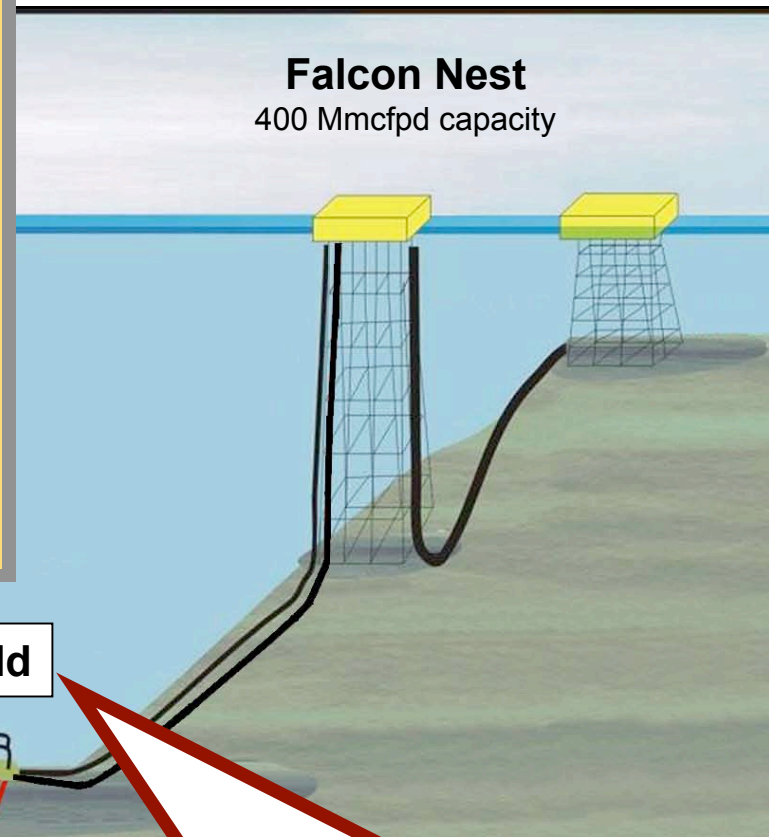
~\$145 million operating cash flow through first 3 quarters of 2003

- ~96% uptime in 2003



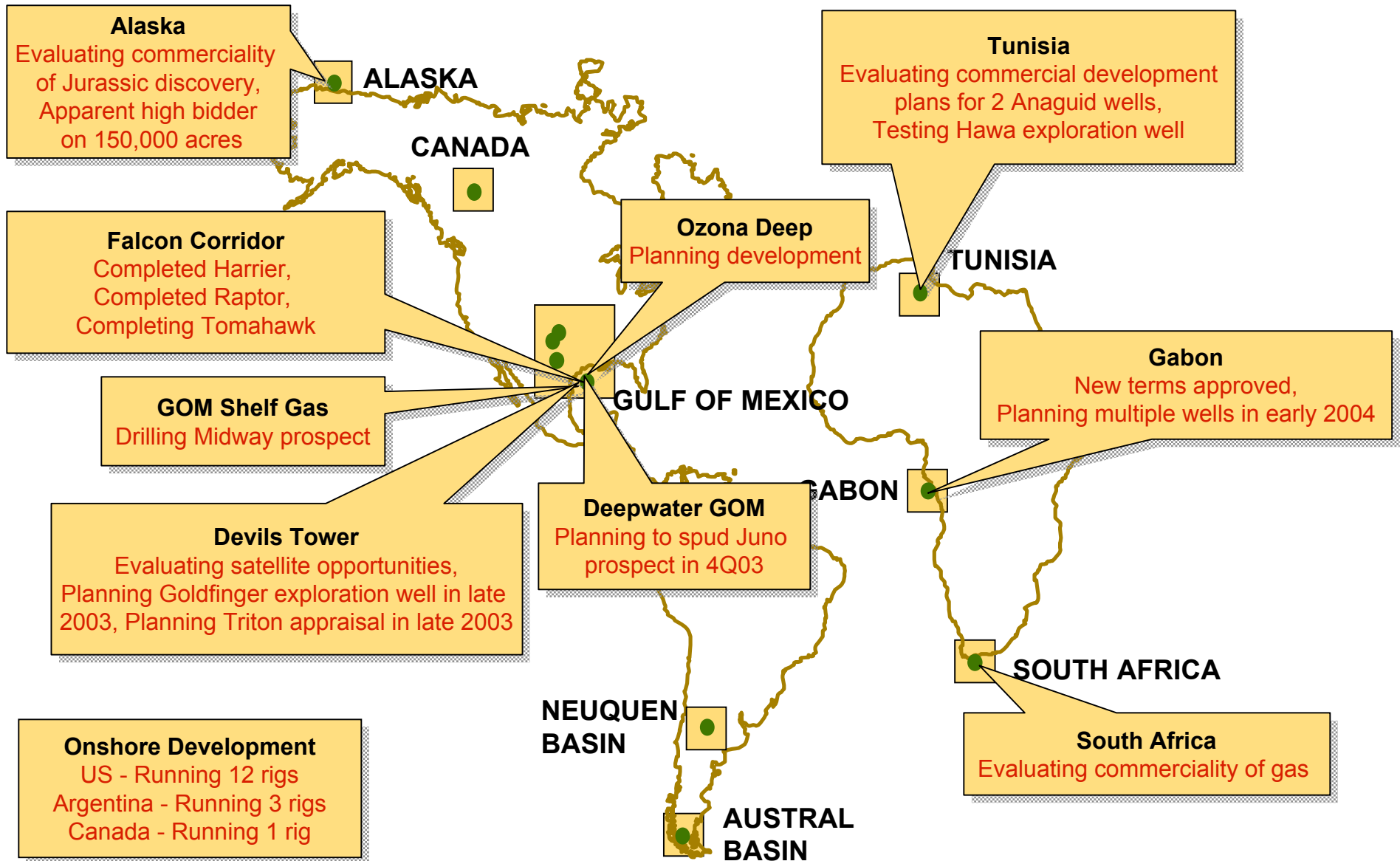
Falcon Corridor

- Harrier
 - Discovered in January 03
 - **1st production expected in 10 – 15 weeks**
- Tomahawk & Raptor
 - Discovered in 3Q '03
- Expect to reach 350+ Mmcfpd from 4 fields
- 2004 Planned Activity
 - Tie in Tomahawk & Raptor
 - Drill additional prospect(s)



- ~\$145 million in operating cash flow from the past two quarters
- Exceeding expected initial production of 175 Mmcfpd

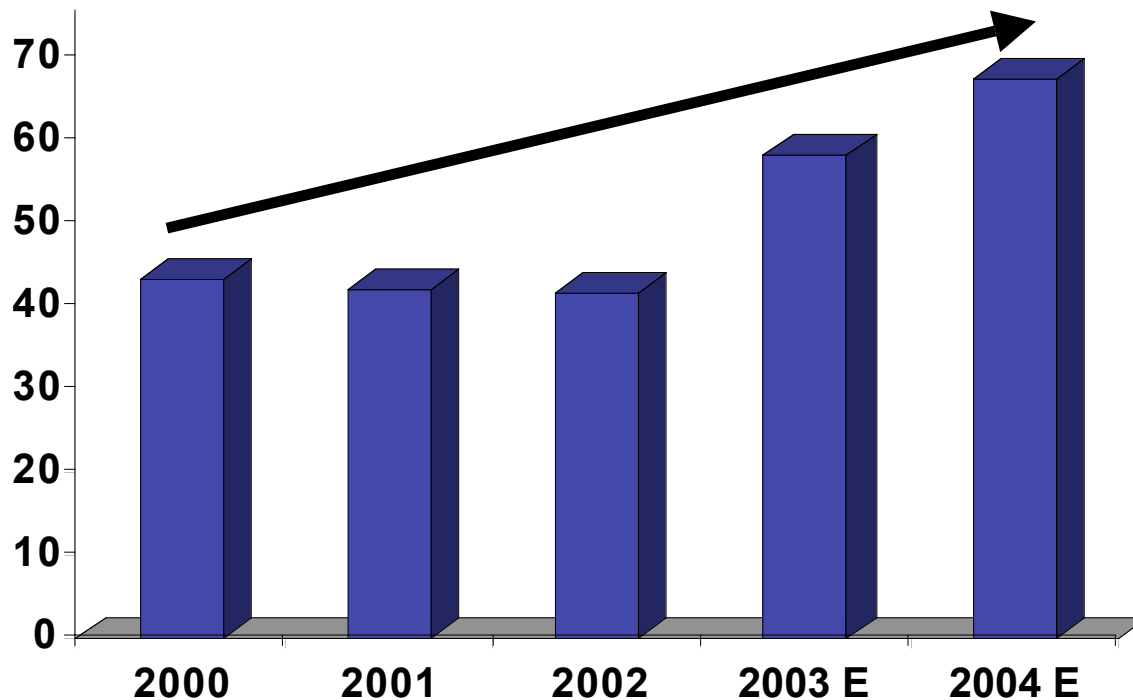

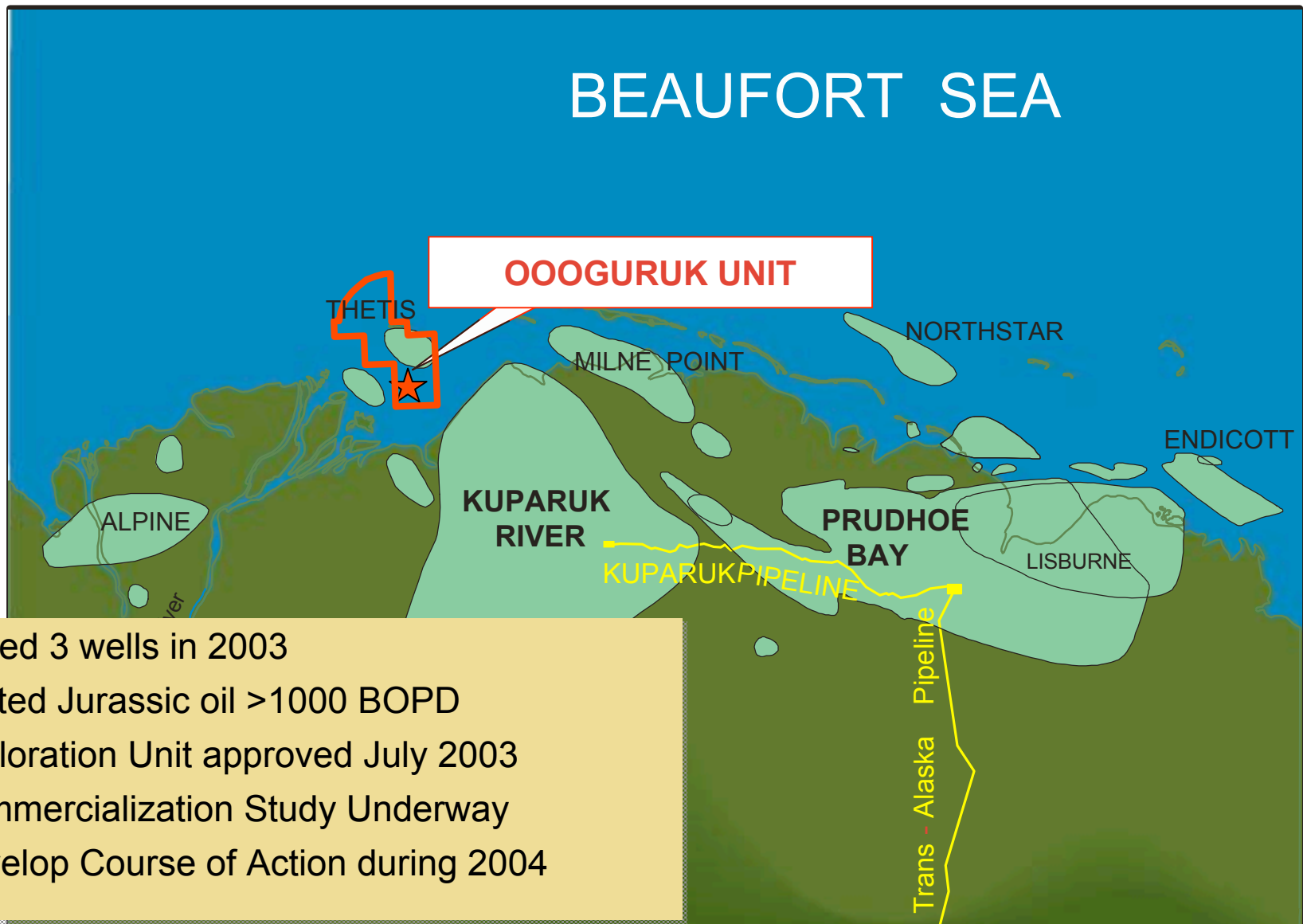
Challenges for Independents in Alaska

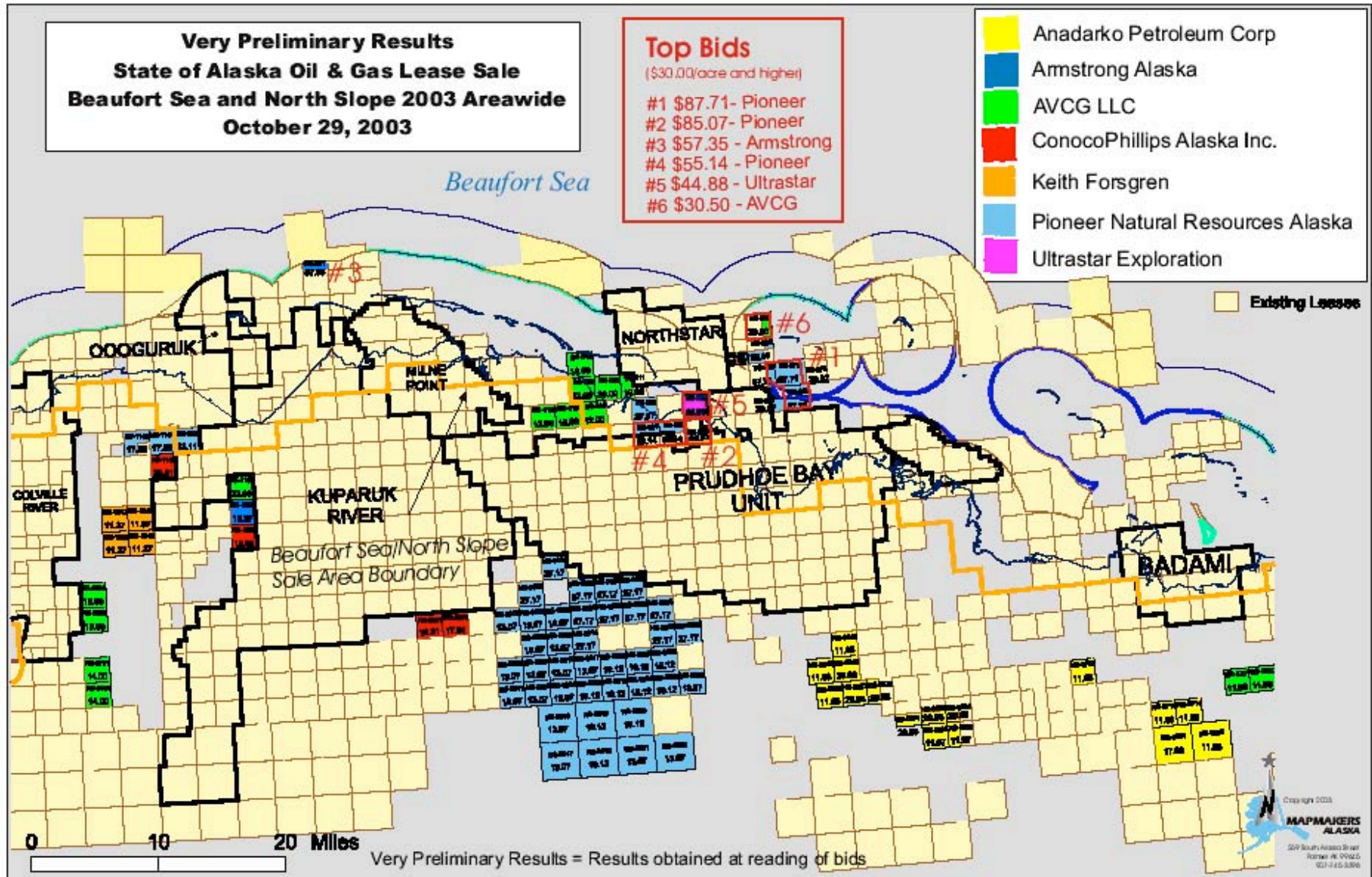
